Old Business:

GBO – Family Care Leave – Tabled in April – Waiting for completion of negotiations with teachers.

Mark as reviewed 6/5/2023.

New Business:

The following J policies are from 2019 that we were waiting for Lindsey to review.

JJIF – Management of Concussions and Other Head injuries – Both our policy and MSMA’s policy cover the same ground but ours is more specific, and I think better. I sent you a copy of MSMA’s for comparison in April. Mark as reviewed 6/5/2023.

JJIF-E – Concussion Information Sheet – No MSMA equivalent. Mark as reviewed 6/5/2023.

JLCC – Communicable Infectious Disease – Basically the same as ours, needs legal reference update. Mark as reviewed 6/5/2023.

JLCDA – Medical Marijuana in Schools – MSMA’s policy and our policy cover the same material but are different in form. We need to add cross references. I sent you a copy of MSMA’s policy in April for comparison. Mark as reviewed 6/5/2023.

JLCDA-E – Request/Permission to Administer Medical Marijuana in Schools. No MSMA equivalent. Mark as reviewed 6/5/2023.

EEAA – Overnight or Out of State Trips – Mark as reviewed 6/5/2023.

EEAA – A – Overnight or Out of State Trip Contract Form – Mark as reviewed 6/5/2023.

EEAA-R – Request for Overnight or Out-Of-State Travel – This policy form was reviewed in March, but Georgia has requested we review it again. To be revised as per yellow highlights and sent to Board for revision July 11, 2023.

We are now beginning our review of policies not looked at since 2020.

ADC – Tobacco use and Possession – There are many changes and additions to this policy including its title - Tobacco-Free Schools: Use and Possession of Tobacco and Electronic Smoking Devices. I am attaching MSMA’s copy. The committee decided, because there are so many changes in this required policy that we should rescind our ADC policy and adopt the MSMA’s ADC policy. This will be sent to the Board at the July 11, 2023 meeting. I would suggest that we bring this policy back to the committee to review optional language on page two.

ADC – R – Tobacco Use and Possession Administrative Procedure – No MSMA equivalent. The committee decided to bring this policy to the Board to be rescinded July 11, 2023, since what is covered in this policy is now in the new ADC policy.

Job Descriptions reviewed – Maintenance; Custodian; Director of Transportation, Maintenance, and Custodial Services; Gifted and Talented Teacher/Technology Integrationist.

We will begin with the B Policies in July. OOPS! There are no B policies that are required to be reviewed. AS it turns out there are only 14 policies from 2020 requiring review. We have already done the first two, ADC, and ADC-R.
