6.1 Levi Robinson from RHR Smith & Company in regards to the audit

- Gives highlights of general fund balances and reserve accounts.
- RLRS is in line with other districts he is reviewing.
- Reserves are continuing to build.

6.2 Shawn Russell & Alison Loud - Technology updates

- ACTEM Conference
 - Association of Technology Educators in Maine. Abby, Ali & Shawn attended this conference this fall. Attended many sessions which were very informative. Cyber security, Aruba networking, technology integration, STEAM nights, access to vendors.
 - Abby & Shawn presented on their digital citizenship program.
 - They will be developing an incident response plan based on sessions they attended.

3D Printer

- Shawn received a grant for a newer 3D printer with more features than the older ones we have
- Ali is working with classroom teachers to integrate 3D printing into classroom lessons and projects
 - Started with volume unit in 5th grade. Students designed their initials in TinkerCAD and then calculated the volume of them. Using them with critical thinkers group. Mrs. Hathaway has used this in Geometry in the past as well.
- STEAM Night (last week)
 - Families from grades 3-5 were invited. Limited to 16 filled fast!
 - Lego Spike Kits from the state grant were used.
 - Built a car and then practiced basic coding to have their vehicles travel through different maps.
 - May apply for future grants for other types of kits
 - Planning more STEAM nights in the future. Pleased with the popularity and participation

6.3 Heidi Deery - School Counseling Update

- Getting Delaney up to speed with school counseling. Her background in social work has been very helpful. Learning nuts & bolts of school settings.
- Using the American School Counselors Association Model
- Want to support students socially and emotionally but would like be able to prioritize
 career education, post-secondary, and aspiration work from the counseling office.
 Challenge in providing full support across preK-12 grade spans by one person. Looking
 for ways to engage kids in their own futures.
 - Mary Richards: What is Heidi's assessment of the current coordination of services so that Delaney can focus on these priorities?
 - Heidi: The student services team (Holly Haggan, Lindsey Savage, Lynda Feins, Heidi & Delaney) works with social emotional curriculum (Second Step). Also the addition of school based therapist has helped.
- From Maine DOE BARR: Building Assets, Reducing Risks
 - DOE is paying for implementation of this research based, 20-year-old program.
 Initial implementation decided to start at a small scale. Started with 6th grade only.

- MS team & student services took an in-person 2 day training in the summer. They are using the BARR curriculum to engage students.
- Building better relationships with students. Using data and structuring meetings in efficient ways. The meeting structure to discuss all students (not just struggling students). Focus is on student strengths. Meetings are action-oriented.
- Supported by "coaches" from BARR weekly and meetings monthly with other educators using the platform across the country. Coaches do on-site visits throughout the year.
